CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely, Nalanda B.Ed. College, Yermarus, Ralchur-584134, Karnataka vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2005-2006/4955 dt. 24.12.2005 for conducting Secondary B.Ed. Course of One year duration with an annual intake of 100 students from the academic session 2005-2006.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide a notarized affidavit dated 13.01.2015. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units from the academic session 2015-16.

3. AND WHEREAS, a Corrigendum No. F.SRO/NCTE/APS02390/B.Ed./KA/2015/69314 was issued to the institution on 04.07.2015 by requesting the institution for B.Ed. Programme with an annual intake of 50 students (one unit) from the academic session 2015-16.

4. AND WHEREAS, the SRC in its 369th Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. According, a Show Cause Notice was issued to the institution on 24.04.2019. The institution has submitted reply on 24.05.2019.

5. AND WHEREAS, the SRC in its 405th meeting held on 13th & 14th December 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 24.12.2021. The institution has submitted reply on 10.01.2022.

6. AND WHEREAS, the SRC in its 406th Meeting held on 19th January, 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Nalanda B.Ed. College, Survey No. 54, Kuknoor Village, Chiksugur Panchayath, Yermarus, Ralchur-584134, Karnataka for B.Ed. programme for 1 basic unit of 50 students".

7. NOW THEREFORE, this order is issued permitting the Institution i.e., Nalanda B.Ed. College, Survey No. 54, Kuknoor Village, Chiksugur Panchayath, Yermarus, Raichur-584134, Karnataka run by Karnataka People's Education Society (R), Police Parad Ground Road, Near Police Bhavan, Kalaburagi-585105, Karnataka for Continuation of recognition for B.Ed. programme for two-year duration with annual intake of 1 basic unit of 50 students subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The Institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, Inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last quarter;
- d. Name of Students admitted during the current session along with qualification, date of admission, etc.
- e. Fee charged from students.
- f. Available Infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.

j. The institution shall be free to post additional relevant information if it so desires.
k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.


12. The institution shall make available the list of students admitted on its official website.

13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.



ORDER

In terms of Section 14(1) of the NCTE Act, 1993 Karnataka People's Education Society, Gulbarga, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Nalanda B.Ed College, Yermarus, Raichur-584134 Karnataka for Secondary(B.Ed) Course of one year duration from the academic session 2005-06 with an annual intake of 100 students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - a. The institution has acquired the land for setting up the teacher education institution.
 - b. The institution has constructed the building for conducting the course on the above mentioned land.
 - c. The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs. 3 lakhs.
 - d. The institution has selected the Principal and Seven lecturers for the said course and the list of faculty members has been approved by the affiliating University.
3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Nalanda B.Ed College, Yermarus, Raichur-584134 Karnataka for Secondary(B.Ed) course of one year duration from the academic session 2005-2006 with an annual intake of 100 students subject to fulfillment of the following.
 - a. The institution will ensure that Principal and Seven faculty members duly approved by affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.

- b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee,
- c. The institution shall shift to its own premises / building within three years from the date of recognition, (in case the course is started in rented premises)
- d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the affiliating University, UGC, State Government etc.
5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.
